- **SaudiNIC** “ Saudi Network Information Center ” is a non-profit entity that is operated by CITC as a part of the IT sector .
- **Mandate**  
**SaudiNIC** is the local domain name registry of the Saudi domain name space (ccTLD) under ( .sa and السعودية )

- **Mission**

"to provide an equitable, just and competent technical and administrative management of domain name registrations for Internet community in Saudi Arabia".

# About SaudiNIC

- **Current Tasks**

- Provide the local registry services
  - Operate the DNS root servers for Saudi domain domains under ( .sa and السعودية )
  - Regulating domain name services
  - Maintain the Domain names records
  - Provide Whois services
- Lead the effort toward fully Arabic domain names
- Coordinating with other GCC, Arab, and International ccTLDs.
- Participating in international events supervised by ICANN, RIPE, ISOC, and WIPO related to domain.

# History of SaudiNIC

- **KACST “ King Abdulaziz City for Science and Technology ” :**
  - **1994:** KACST contacted IANA and ask to manage the domain name space for the country code (ccTLD) of Saudi Arabia (.sa)
  - **1995:** KACST was delegated the responsibility of managing and administrating the Saudi ccTLD (.sa)
  - **1997:** Registration of first domain name : kacst.edu.sa
  - **1998:** ISU was established and SaudiNIC became one of its departments



# History of SaudiNIC

- CITC “ Communication and Information Commission ” :
  - **2006** : The movement to CITC
  - **2009** : First major update for the regulation.
  - **2010** : Major update to all the internal systems
  - **2010** : Starting the Arabic domain names registration under ( .السعودية )
  - **2011** : Starting the 2DL domain names registration
  - **2011** : Update the regulation in preparation for introducing fees and registry-registrar module



# SaudiNIC's Services

- **As a Local domain names registry**
  - **National service** : running the root servers for the Saudi domain name space .
  - **Critical service** : SaudiNIC infrastructure must be working correctly all the time.
  - If not, access to all websites using Saudi domain names will be effected .
  - Work procedures must insure the safety and security of the domain names records .

# SaudiNIC's Services

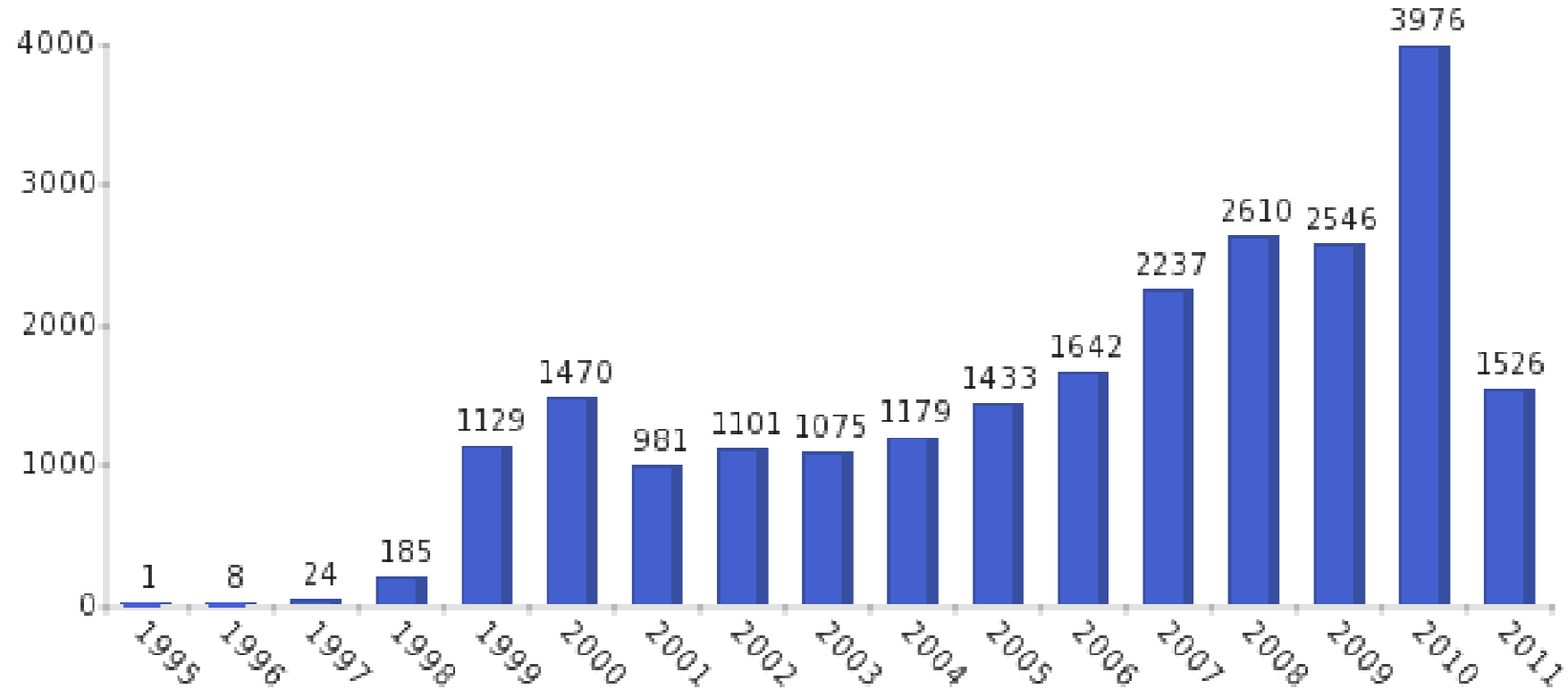
- **Services for domain name registrants**
  - Day to day services like registration, modification, clients inquiries, .. etc.
- **Services for Local authorities and regulatory entities**
  - Maintain the domain names records
  - Ensure that all the regulation and policies are applied .

- **General Statistics**
  - **Registered domains : 23,343 domains**
    - Relation and documents are still required
    - Domain hosting is still required
  - **Registered Arabic domains : 988 domains**
    - Registration was opened by the end of 2010
  - **Registered second level domains : 669 domains**
    - Open phase will start next week .

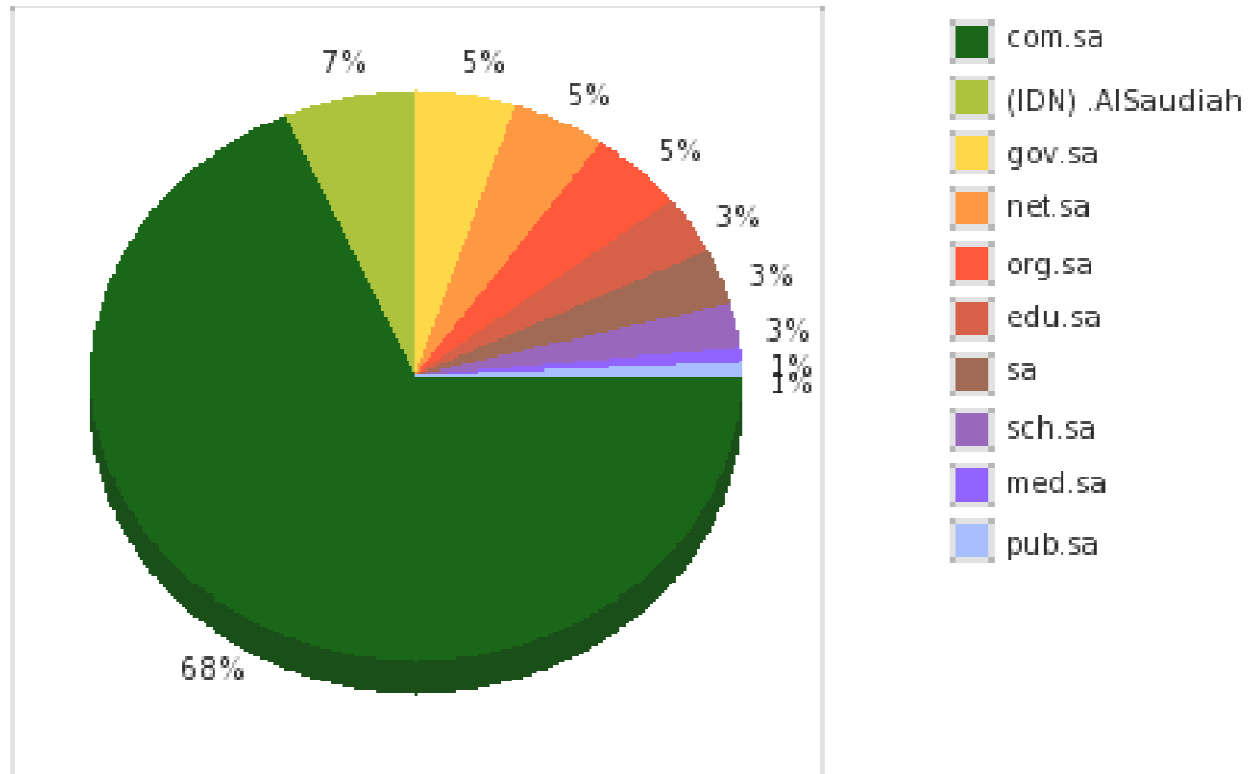
Number of registred domains up to 26-Apr-2011





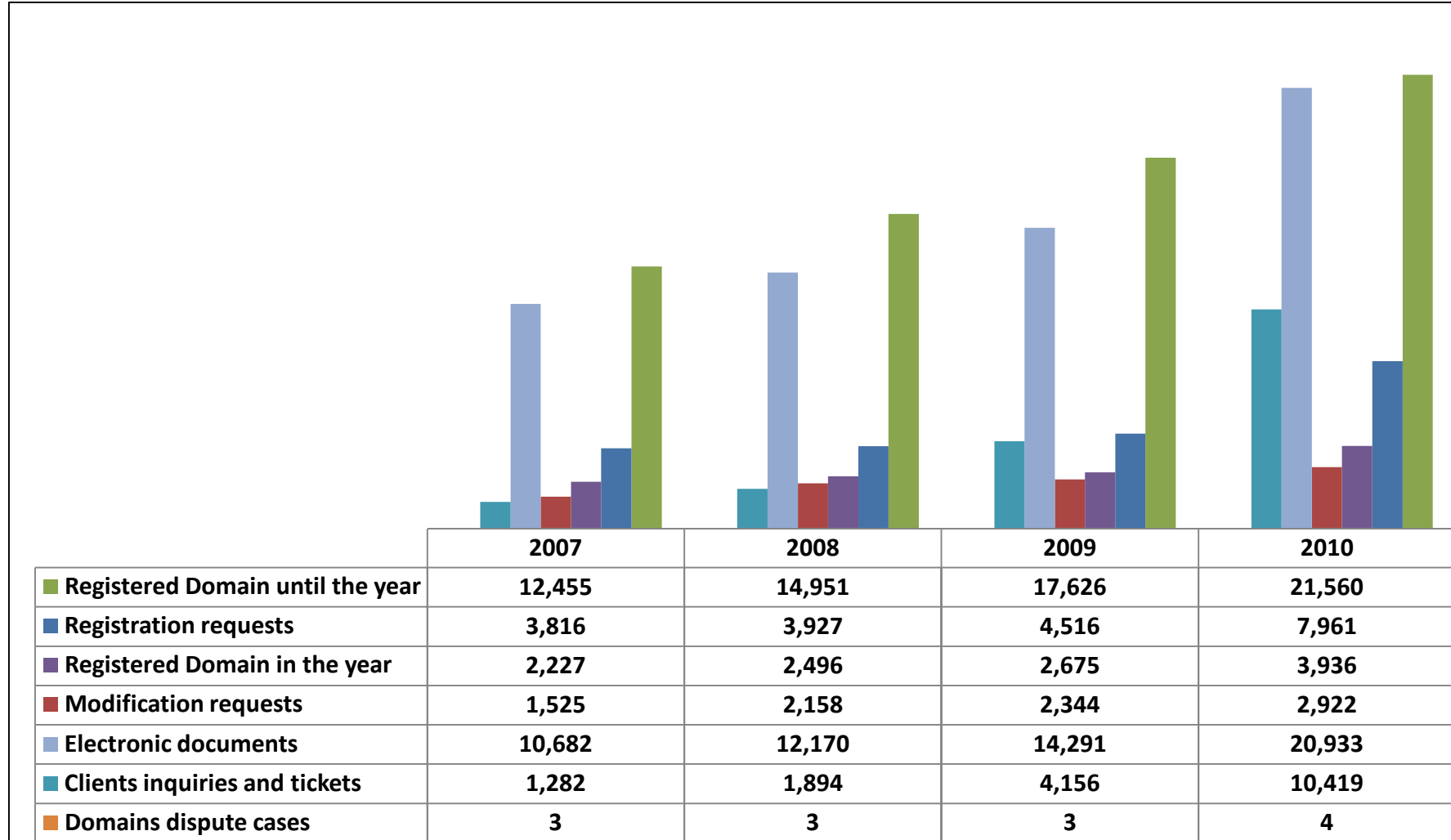

# Accomplishments

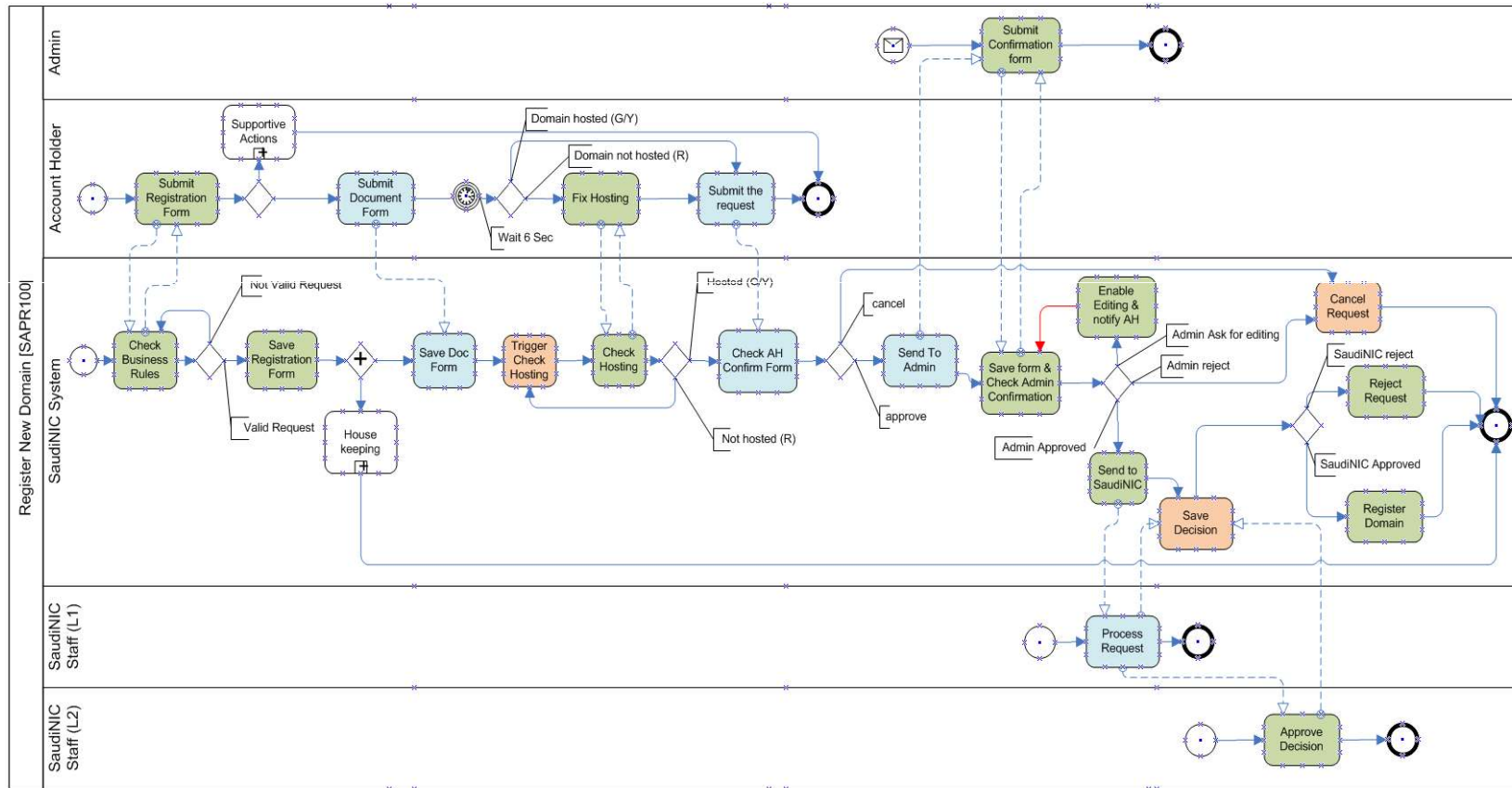
- **Registration services**

  - Electronic documents management system ( **FARIZ** )



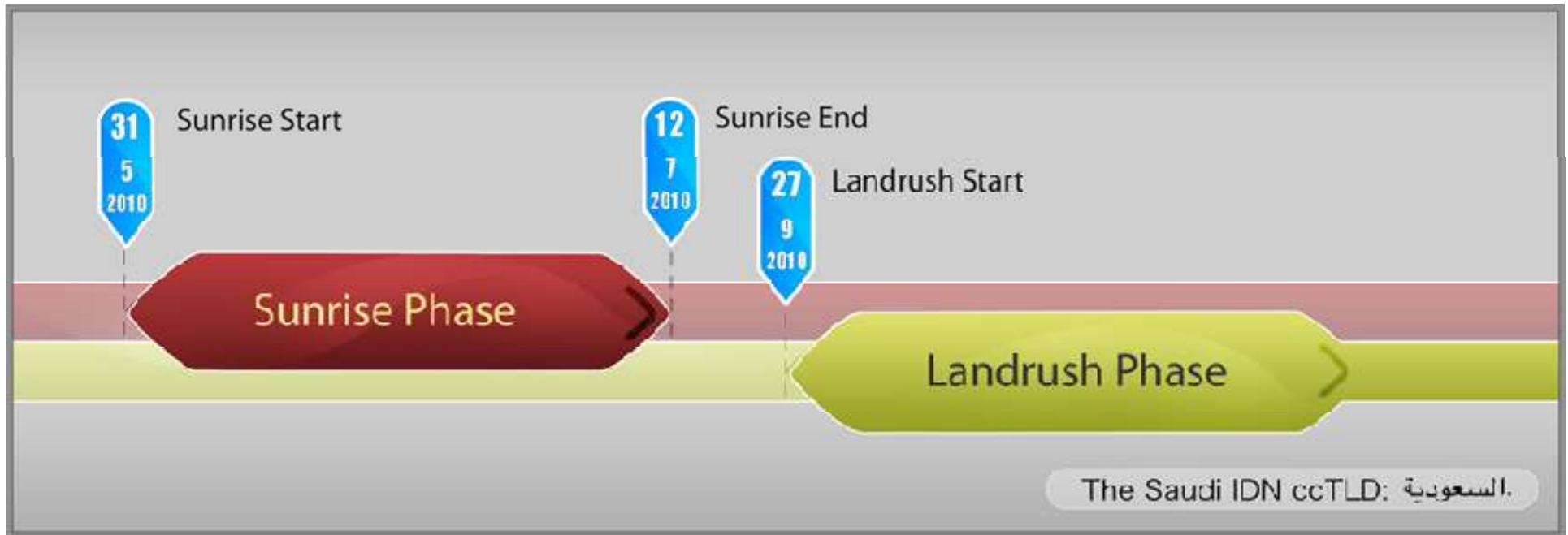
# Accomplishments

- Introduced ADN in a phased approach

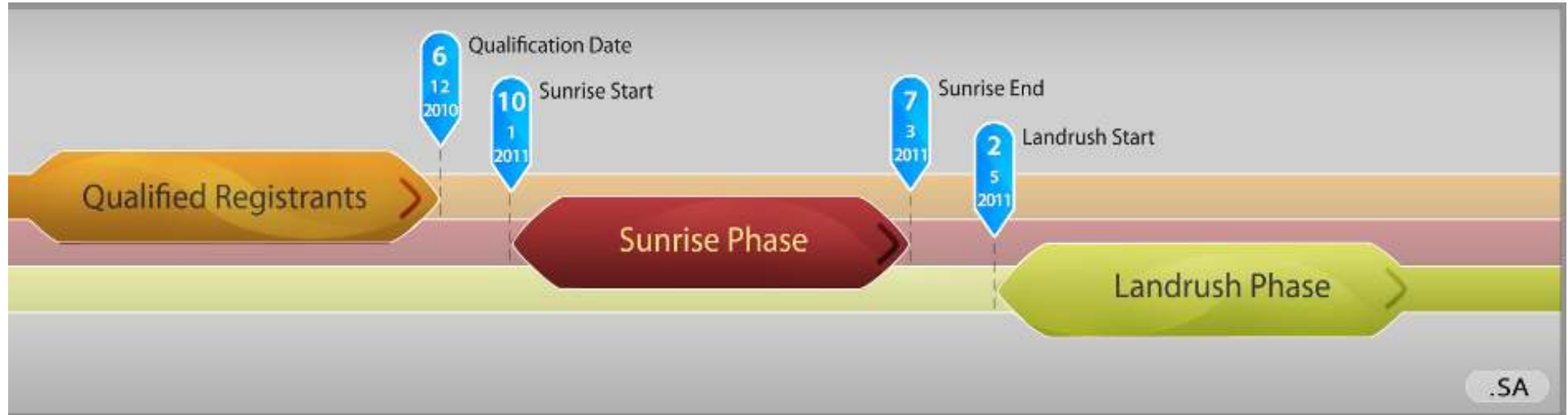
